**Decision on the establishment of the Stung Sen Basin Committee Director Board**

**The Chairman of Tonle Sap Authority**

- Having regard to the Constitution of the Kingdom of Cambodia;
- Having regard to Royal Decree n°0913/903 of 24 September 2013 on the appointment of the Government of Kingdom of Cambodia;
- Having regard to Royal Decree n°02/94 of 20 July 1994 on the Prakas related to legal framework for the preparation and functioning of the government;
- Having regard to Royal Decree n°0699/08 of 23 June 1999 related to the Law on the creation of the Ministry of Water Resources and Meteorology;
- Having regard to Royal Decree n°06/94 of 30 October 1994 related to the Law on civil servants;
- Having regard to Royal Decree n°0310/258 of 24 March 2010 related to the ratification of article 3, article 5, article 6, article 9, article 10 and article 12 of the Royal Decree n°0609/705 of 29 June 2009 on the creation of the Tonle Sap Authority;

- Having regard to Decision n°015 of 2 March 2015 on the creation of the Stung Sen Basin Committee in Preah Vihea Province;
- Having regard to the needs of Tonle Sap Authority;

## **Decides:**

### **Article 1**

Establishment of the Director Board of the Stung Sen Basin Committee, with following composition:

### **Article 2**

The Director Board of Stung Sen Basin Committee has following responsibilities:

- Implement the project of Integrated Water Resources Management in the Stung Sen basin;
- Prepare and manage the administrative and financial functioning of the Stung Sen Basin Committee;
- Prepare and ensure appropriate functioning of the offices in Kompong Thom and Preah Vihea Provinces;
- Prepare the management of those offices. Decide of the number of permanent staff to ensure the good functioning of the office;
- Follow the objectives set by the Basin Committee.

### **Article 3**

The Director Board prepares, in collaboration with the Tonle Sap Authority, internal rules for the good functioning of the project.

### **Article 4**

The Stung Sen Basin Committee of Kompong Thom and Preah Vihea Provinces, the Executive Basin Committee, the members of the board as mentioned in article 1, shall be obliged to apply this decision from the date of signature.
