- Having regard to the Royal Decree n°0508/017 of 24 June 2008 related to the Law on Administrative Governance for Provinces and Districts;
- Having regard to Decree n°216 of 14 December 2009 on the duties, objectives and role of the Governor in the management of Provincial Committees and District Committees;
- Having regard to the Prakas (implementing circular) n°4274 of 30 December 2009 on the establishment of offices in each Provinces and Districts and on duties and functioning of those offices under the responsibility of the Ministry of Interior;
- Having regard to the inter-ministerial Prakas n°324 of 1st March 2013 related to the legal framework for the creation, preparation and functioning of Executive Committees of the Province and Districts;
- Having regard to the letter n°024/15 of 10 February 2015 of the Tonle Sap Authority;

The administration of the Province, provincial representatives of the involved Ministries, NGOs, administration of Districts, administrations of Municipalities, and any persons mentioned in article 1 and 3, shall be obliged to apply this decision from the date of signature.
